THE COMPLAINANT SUBMITS AS FOLLOWS:

1. It is submit that the accused herein committed illegal acts by using her facebook i.e. <http://www.facebook.com/karatekalyani> in her verified profile of facebook she used to posted the photo and name of the deceased minor girl which is the matter of crime No. 344/2021 on the file of PS Saidabad.

2. It is submitted that the accused posted on her facebook wall about the brutal incident and the deceased photo on the facebook publicly which went in number of shares in her post link ([https://m.facebook.com/story.ph? Story-fbid-2303340989808705 & id+100003984783186](https://m.facebook.com/story.ph?Story-fbid-2303340989808705&id+100003984783186), but as per the declared law photo or name of ht victim girl either major or minor any person should not disclose the name or photo of the rape victim, but here the accused herein in her facebook directly posted the photo of rape victim and name of the rape victim which pertains to the crime No. 344/2021, not only in one post she has posted 2 posts, link of the second post is ([https://mm.facebook.com/story.ph? stoy-fbid+2305621869580617 & id+10003984783186](https://mm.facebook.com/story.ph?stoy-fbid+2305621869580617&id+10003984783186)) in one post she disclosed the name of the victim and in one post she has posted the photo and name of the victim girl. Therefore, in the view of the above circumstances.

3. It is submitted that on 18.09.2021 the complainant contacted Mr. Sekhar Ashok SIP of PS Cyber Criems, thus the officer instructed the complainant to approach PS Jagadgirigutta and report the same, as per instructions, the complainant approached the PS Jagadgirigutta, but they failed to register the case against the accused herein.

4. It is submitted that the complainant has not filed any case or cases 5gainst the accused person pertaining to the same cause of action in any court of law including High Court of Judicature at Hyderabad.

That the cause of arose on 18.09.2021 the accused herein posted the absence photos of victim girl in social media without following due process of law.


JURISDICTION :
