- 2. <u>Application Process:-</u> The aspiring applicants satisfying the eligibility criteria in all respects can submit their application through <u>ON-LINE</u> mode. The On-line registration of application will be made available on AIIMS, Bibinagar's official website i.e. https://aiimsbibinagar.edu.in. The link for submission of online applications in respect of above said posts along with other relevant information will be activated on the date of publication of advertisement on Employment News / Rojgar Samachar or earlier (as posted on the website).

- 3. For filling up of Online application, candidates must have the following pre-requisites ready:
 - (i) Valid e-mail ID.
 - (ii) Scanned Passport size photograph of candidate (in JPG format).
 - (iii) Scanned Signature of the candidate (in JPG format).
 - (iv) Online payment details of the required Application Fee.
