## TERMS AND CONDITIONS for Retired Judicial Employees:

- 1. Applicant shall be the only persons retired as Members of TJMSS.
- Applicant shall be the persons who have retired in the corresponding or higher Categories of Telangana Judicial Ministerial and Subodinate Services.
- 3. Applicants shall be the persons of sound health and active habits.
- Applicants shall be the persons with proven record of ability, good performance and integrity,
- 5. Applicants shall be persons who have not received any punishment for any misconduct in disciplinary Proceedings while in Service.
- 6. The individual must not have completed 65 years of age as on 01.07.2022.
- 7. Persons selected have to produce Fitness Certificate and enter into Agreement/Contract with the Principal District and Sessions Judge, Nizamabad on such terms and conditions as the appointing authority deems fit, proper and necessary regarding the conditions of appointment and service and on all other required particulars.
- 8. The candidates are directed to produce a copy of Reitrement proceedings issued by the concerned District Judge or copy of the Pension Payment Order (PPO) issued by the competent authority.

IN CASE OF NON AVAILABILITY OF RETIRED MINISTERIAL STAFF OF JUDICIAL DEPARTMENT, THE CANDIDATES FROM OUTSIDERS WILL BE CONSIDERED FOR APPOINTMENT.
