3) **Dates of submission of Applications:**

4) **Education qualifications and Age:**

Name of the Post : ASHA
Requisite Qualifications : 10th Class / Intermediate
Performance based incentive (Honorarium) : Rs.10,000

5) **Age:**

The age should be in between 25 to 45 years as on 01.12.2022

Note: Maximum age limit mentioned above is subject to issue of orders from the government

6) **Eligibility Criteria :**

- ❖ Asha must be a women resident of the urban area - Slum/Vulnerable

clusters

- ❖ Preferably married / widow / divorced / separated women
- ❖ Minimum educational qualification shall be 10th class / intermediate
- ❖ Fluency in Telugu reading and writing with effective communication skills and leadership qualities

07) Fees :

The candidates applying for the posts should invariably pay Fee at Rs.400/- to be credited into the Bank Account No.91155283596 of the District Medical and Health Officer, Nandyal at Andhra Pragathi Graameena Bank, Sanjevanagar, IFSC Code: APGB0003110. The Bank Receipt should be submitted alongwith the Application Form. Demand Drafts / Banker Cheques / individual cheques will not be accepted.

METHOD OF SELECTION :

08) Selection Process :

- a) Total marks : 100
- b) 50 marks will be allocated against marks obtained in the qualifying examination
- c) 50 marks will be given for local status / service (worked in any NGO organization's / marital status)

09) How to apply:-

- A. Application is available in <https://nandyal.ap.gov.in> website
- B. Candidates shall apply only through offline only
- C. The start date for submission of applications with all relevant documents is from 12.12.2022 to 15.12.2022
- D. The last date for submission of application is 15.12.2022 by 05.00 pm in O/o the District Medical and Health officer, Nandyal
- E. The following documents should be submitted along with the application
 - a) Pass port size photo
 - b) SSC or equivalent certificate
 - c) Caste certified issued by MRO concerned in the absence of proper caste certificate, the candidate will be considered as OC candidate
 - d) Ration card as a proof of marriage
 - e) Residence certificate attested by the ward administrator of

concerned ward secretariats

10) Instructions

- a) The appointments are purely on temporary on basis and liable for termination at any time

11) Debarment

- a) The candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all regarding his / her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidate for this recruitment & future recruitments.
- b) The department is vested with duty of conduction recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt.
- c) The act by any one casing or likely to cause breach of duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient cause for rendering such questionable means ground for department.
