Sub: APTWREIS (Gurukulam) Tadepalli - **EMRS Wing** - Admissions into entry point Class i.e., 6<sup>th</sup> in all EMR Schools and backlog vacancies (if any) in Classes 7<sup>th</sup>, & 8<sup>th</sup> and 9<sup>th</sup> for the Academic Year 2023-24 - Conduct of written test – Certain Guidelines communicated – Regarding.

The Ministry of Tribal affairs (MoTA), Government of India have established National Education Society for Tribal Students (NESTS) for maintaining Ekalavya Model Residential Schools (EMRS) across the country. The NESTS, MoTA have sanctioned (28) EMRSs in Andhra Pradesh. All are functioning under the aegis of APTWREI Society (Gurukulam).

In the refence cited, the Ministry of Tribal Affairs, GoI, New Delhi have communicated the draft admission guidelines for the year 2023-2024. Based on the draft admission guidelines, the following is the reservation criteria which should be maintained in all EMR Schools across the Country.

The Gurukulam has decided to take up state level admissions for the Academic Year 2023-24 from class 6th and backlog vacancies for 7th,8th and 9th classes into (28) EMR Schools through written test on merit basis.

**1. Admission Eligibility:**

The minimum and maximum age limit (as on 31<sup>st</sup> March of the year in which admission is sought) for admission in Ekalavya Model Residential Schools in various classes is given below: (Child born on 1st April should also be considered.)

**Note:**

- I. The maximum age limit can be relaxed by two years in case of Differently abled children by the State/UT EMRS Societies.

**2. Class Strength and Competent Authorities:**

A fully functional EMRS shall have 2 sections in each class from VI to X and 3 sections in Class XI & XII (one of each stream viz. Science, Commerce & Humanities) with a total sanctioned strength of 480 @ 30 per section per class.

**3. General Eligibility Criteria:**

- I. The candidates belonging to the reservation categories mentioned at the table 2.4 of Admission Guidelines Academic year 2023-2024, in respect of their domiciled State/ UT are eligible to apply for admission.
- II. A candidate should fulfill the age criteria as mentioned at point 2.1 Admission Eligibility. In case of doubtful cases of overage in comparison to the age recorded in the certificate, they may be referred to the District Medical Board for confirmation of the age. The decision of the Medical Board will be treated as final and binding on both the parties.
- III. Candidate should not be rusticated from any of the schools.

#### 4. Reservations in Admission:

In accordance with EMRS Guidelines November 2020 & duly approved Note for the Cabinet Committee on Economic Affairs (CCEA) vide Ministry of Tribal Affairs letter No. 17011/03/2019-EMRS (Part – I) dated 05.12.2021, the below mentioned reservation criteria shall be followed for granting admissions in EMRSs:-

##### I. Reservation Table:

<b>Note:</b> 1. It includes citizens victim of LWE and Police/ Paramilitary/ Armed Forces personnel who have lost their lives fighting LWE. 2. 5% i.e 3 seats out of 60 are reserved for Differently abled children. These seats shall be carved out @ 2 seats from ST and 1 seat from others.			
(v)	Children of Staff of EMRSs/EMDBSs/ CES/ Doctors/ Paramedical staff of Government Hospital serving in the same block.	Over and above the sanctioned strength of 30 students per section per Class with the restriction of maximum 40 students in one section.	

**Note:** The Children of Staff of EMRSs/ EMDBSs/ CES/ Doctors/ Paramedical staff of Government Hospital serving in the same block shall be given admission over and above the prescribed strength of 30 students per section per Class.

This facility shall be extended to only **eldest two surviving children**. The Principal is authorized to admit the children of staff in the respective EMRSs/ EMDBSs/ CES where the parent is working and Doctors/ Paramedical Staff of Government Hospital working in the same block.

**Further, no additional financial implications are to be borne by EMRSs/ NESTS/ MoTA as these children shall not be a part of EMRS Scheme. Since, no fee is prescribed in EMRS Scheme, hence, the same shall not be charged from these students.**

**II.** The number of seats for boys and girls will be equal. However, the EMRSs which are running as only Boys or Girls schools shall have to go for smooth progressive transition into co-educational schools starting with class VI in the next academic year considering the local circumstantial context.

**III.** Transgender category students shall not be denied admission subject to fulfillment of eligibility conditions. **Transgender category to be considered under boys' category.**

**IV.** For point no. iv of Reservation Table 2.4 (I), the proposed consolidated quota of reservation is 10% and no individual quota is allocated to any category mentioned therein. The State/ UT EMRS Societies are allowed to decide upon the percentage and priority of individual quota of the categories mentioned therein depending upon local situations & circumstances.

**V.** If a child belongs to more than one reservation category then he/ she shall be allowed to avail the benefit of **only one reservation category with the highest reservation percentage.**

**VI.** **The merit list for each category shall be prepared separately on the basis of the Selection Test** . The cut off marks shall be different for different reservation categories and for boys' & girls'.

**VII.** Children of Staff of EMRSs/ EMDBSs/ CES/ Doctors/ Paramedical staff of Government Hospital serving in **the same block shall be granted admission directly in any class.**

It is clarified that the children of Staff of EMRSs/EMDBSs/CES/Doctors/ Paramedical staff of Government Hospital serving in the same block shall not be a part of EMRS Scheme and no financial implications in respect of these children shall be borne out of the fund released by NESTS/ MoTA .

### **De-Reservation:**

**In case of insufficient registration/non-registration/insufficient selection in (EMRSST) or EMRSLT/ insufficient turn out for admission, the seats reserved for a particular reservation category shall be de-reserved into other reservation categories. (Ref: para 5.7 of admission guidelines communicated by NESTS 2023-24).**

## 5. Admission Selection Procedure

Admission for Class VI shall be made strictly on the basis of an entrance test called Eklavya Model Residential school Selection Test (**EMRSST**) and **basis of the 28 options exercised** by student in the online application registration.

## 6. Admission announcement

State/UT EMRS Societies shall notify students about admission to the new session through wide publicity by means of **Doordarshan/ All India Radio/ State EMRS Societies website/web portal, EMRS websites, local newspapers, pamphlets etc.**

## **7. Eligibility of students for admission into EMRSs across the state:**

In the admission guidelines, the NESTS have informed that, the seats should be open to all ST children of the state who have no specific reservation quota for the ST resident of Block / Taluka / Tehsil / District in which EMRS is situated. Notwithstanding, the State / UT EMRS Societies may exercise their privilege to fix specific quota, not exceeding 30% for the ST candidates belonging to block / taluka / tehsil / district in which the EMRS is situated.

It is clarified that the candidates belong to the reservation categories as mentioned in the table across the state are eligible to apply for admission in any of EMRS irrespective of the fact that whether an EMRS is running in their block / Taluka / Tehsil / District of residence or not.

## **8. Annual Income**

The annual Income of the parent shall not exceed Rs.1,00,000/- for admission into any Residential Schools. **(Need not produce income certificate in case of white ration card holders as per GO.MS No: 229 Dated 23-06-2017)**

## **9. Submission of application form:**

All the eligible students shall submit the filled applications through online [aptwgurukulam.ap.gov.in](http://aptwgurukulam.ap.gov.in) (or) approach the nearby Gurukulam institutions with all details to fill the application and handover it to the principal. The Principals in turn shall upload the application through online.

## **10. Role of the Convener Principals of EMRS and other Gurukulam Principals:**

- i. The Principals concerned shall take initiative steps for pooling number of applications by giving wide publicity with the help of Village volunteers concerned.
- ii. The Convener Principal shall issue a press note in the local papers regarding the admissions in EMR Schools with the approval of the Project Officer, ITDA / JC of Non-ITDA through Dy. Director (TW) / DTWO concerned.
- iii. All the Principals of Gurukulam institutions shall make necessary arrangements for uploading the applications of the students for admission into EMR Schools.
- iv. After applying through online, one number will be auto generated per each student. The Principal shall record the auto generated number on the Registration form and give proper acknowledgement to the student / parent / guardian concerned.
- v. The Convener Principal shall coordinate with the Principals of Gurukulam institutions in their district from time to time regarding online the applications, status etc., until completion of the entrance examination.
- vi. The Principals of the examination centers shall act as Chief Superintendents and the Convener Principal shall act as Departmental Officer. If, the entrance test is conducted at Convener point institution, the senior most Principal of other Gurukulam institution in that district shall act as Departmental Officer. (List will be communicated by Gurukulam).
- vii. The Chief Superintendent and Departmental Officer concerned shall attend to Gurukulam Head Office for takeover the confidential material for conducting the Entrance Examination. The date will be intimated by Gurukulam later.



- viii. If any disputes in this regard shall bring to the notice of the Gurukulam for orders.
- ix. Maintain transparency in the admissions process.

## 11. Role of Gurukulam Head Office

- i. Gurukulam shall issue the paper notification for calling applications from the eligible students for appearing entrance test for admission into EMRS schools.
- ii. Creating a separate URL ID and will be linked to Gurukulam Website i.e., <https://apwgurukulam.ap.gov.in> in coordination with APCFSS.
- iii. Identifying the locations for conduct of Entrance Test for admission into EMR Schools.
- iv. Generating the district wise, examination centre wise nominal rolls.
- v. Preparation and supply of question papers.

- vi. Conducting of spot valuation (centers will be intimated later).
- vii. Preparation and communicating the merit lists as per the reservation category and options of the students.

## 12. Role of District level administration:

- i. The Project Officers of ITDAs / Joint. Collectors of Non-ITDA districts & Dy. Director, TW / DTWOs shall ensure that, to extent cooperation for smooth conduct of the entrance test at their district concerned.
- ii. Issue necessary directions to the supporting staff for giving wide publicity at field level for getting more number of applications.
- iii. Gurukulam shall communicate the merit lists of each EMRS institution as per the choice of the candidates exercised in online as per the reservation of seats. The Project Officers of ITDAs / Jt. Collectors of Non-ITDA districts shall ensure that, to monitor the admission process.
- iv. The Dy. Directors of TW / DTWOs shall supervise the entire process until completion of the admissions in (28) EMR Schools in a smooth manner.
