III. PERIOD OF CONTRACT APPOINTMENT:

1. The tenure of contract appointment will be 1 to 3 years.
2. The contract of appointment may be terminated by either side giving 1 – 3 months' notice or by paying the contractual remuneration of one to three months in lieu of notice period, if the circumstances so warrant.

IV. CONDITIONS:

1. Candidates who have been shortlisted will only be called for interview.
