1. It is decided to fill up the vacant posts of CASS in the hospitals under the administrative control of the Directorate of Secondary Health, A.P(formerly APVVP) through Walk-in Recruitment-V on **Regular basis / Contract basis**.
2. Local candidates are eligible to apply for the Regular and contract appointments. Non-Local Candidates will be considered only for contract appointment. The candidates who are not eligible for regular recruitment will be considered for contract appointment as per reference 12th cited. Specialist doctors who don't complete 70 years of age as on 01.07.2023 are eligible for contract appointment.
3. The tenure of contract appointment is initially for a period of one year and extendable for further period subject to satisfactory service and other eligibility criteria.
4. Eligibility criteria and selection procedure are mentioned in Annexure. Application proforma is attached here with, to enable the interested candidate to attend the Walk-in Recruitment along with the duly filled in form.

6. Merit lists will be communicated through Whats App /e-mail and counseling for choosing place of posting will be conducted through physical/ZOOM counseling. If, selection and counseling could not be completed on the day of Walk-In-Recruitment, counseling will be conducted through ZOOM conference on the next day and as such candidates need not wait on the following day.
7. Interested candidates are advised to attend the **Walk-In-Recruitment-V** along with the following original certificates and one set of Xerox copies for Walk-In- Recruitment on the day scheduled.

 - Specialist doctors who retired from Govt. service and who did not complete 70 years of age as on 01.07.2023, shall submit copies of retirement order and Pension Payment Order.
 - Study certificates from classes 4th to 10th. In case of private study, local candidature certificate for the seven years period preceding to 10th class in the prescribed pro forma from the Tahsildar concerned in prescribed proforma vide Sub clause (ii) of clause (a) of para 7 of the Presidential Order (pro forma is herewith enclosed). Candidates migrated from Telangana state shall submit certificate of local candidature as per G.O.Ms.No. 132 & 133, dt.13.06.2017. In absence of the suitable certificate, the candidate will be considered as non- bcal and he/she would be considered for contract appointment only.
 - Social status including valid EWS certificate issued by the competent authority, in absence of which candidate will be considered as open category. If communal reservation is claimed under any category, the same candidate will not be considered for EWS reservation.
 - Certificate of disability issued in SADAREM in case of orthopedically disabled.
 - EX-service man certificate as applicable.
 - Contract Service certificate in the specialty concerned from the controlling officer concerned i.e., DM&HO / DCHS/ Superintendent of GGH /Principal (for the period after completion of PG degree).

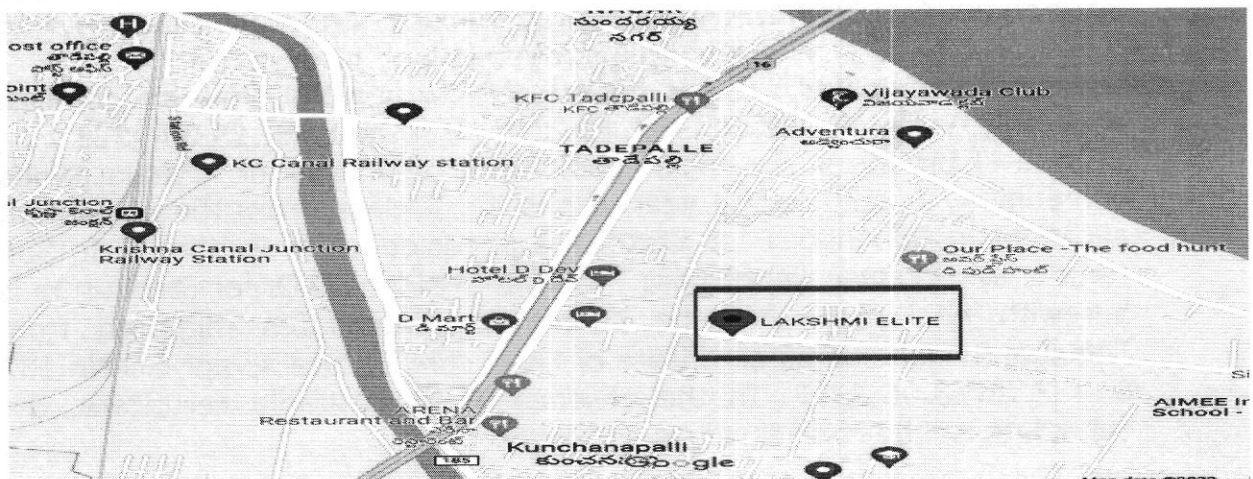

2. Age:

Upper age limit is 42 years. Age will be reckoned as on 01-07-2023 with the following relaxations as applicable.

- i. For SC, ST, BC and EWS : 05 (Five years).
- ii. For ex-service Men: 03 (Three) years in addition to the length of service in armed forces.
- iii. For Physically Challenged persons: 10 (Ten) years.
- iv. Specialist doctors will be allowed to contract appointment up to the completion of the age of 70 years as on 01.07.2023.

3. Reservation:

Reservation will be as per A.P.State Govt. Rules in force. Contract appointment will be in relaxation of the Rule of Reservation in terms of reference 14th cited.

4. Local Candidature:

- a) A.P.Public Employment (Organization of local cadres and regulation of direct recruitment) orders issued in G.O.Ms.No.674, General Administration (SPF- A) Dept., dt.20.10.1975, G.O.(P).No.763, General Administration (SPF-A)Dept., dt.15.11.1975 and G.O.Ms.No.124, General Administration(SPF-A) Dept., dt. 07.03.2002 read with Memo no.1585/D1/2014, HM&FW(D)Dept., dt.18.08.2014 are applicable for regular recruitment. Candidates local to Andhra Pradesh only are eligible for regular recruitment. (Local candidates: who studied 4th Class to 10th Class in the State of A.P. and candidates who migrated to any part of AP from the State of Telangana within a period of 3 years from 2nd June 2014 as per G.O.Ms.No. 132 General Administration Dept., Dt.13-6-2016 & G.O.Ms.No. 133 General Administration Dept., 13.06.2016.
- b) Non-local candidates will be considered for appointment on contract basis only as per G.O.Rt.No.367, HM&FW (D1) Dept., dt.16.05.2023.
- c) In case of private study, local candidature certificate for 7 years period immediately preceding the year of passing X class, from the competent authority in Appendix-I i.e. certificate of residence prescribed vide Sub clause (ii) of clause (a) of para 7 of the Presidential Order (pro forma is herewith enclosed) shall be submitted. Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 dt:13.06.2017. In the absence of the suitable certificate, the candidate will be considered as non-local.

- d) The Residence Certificate will not be accepted if a Candidate has studied in any Educational Institutions up to SSC or equivalent Examination such candidates have to produce study certificates invariably.

5. Pay and Allowances:-

For regular appointment:-

- Scale of Pay Rs.61,960 to Rs.1,51,370 and other allowances as admissible under the rules in force from time to time.
- The specialist doctors posted in the hospitals located in tribal area will be paid 50% over basic pay as an additional incentive.

For contract appointment:-

Contract appointment will be taken up after completion of selections on regular basis against the left over notified vacancies.

6. Selection Procedure:

- Merit list will be prepared with the candidatures of all the applicants who attended Walk-In-Recruitment-V based on the following marks matrix.
- Total Marks: 100.
- 75% of the marks obtained in PG Degree / DNB and 65% of the marks obtained in PG Diploma.
- In the absence of PG marks memo, marks obtained in PG Degree / PG Diploma / DNB will be considered as 50%. 75% of 50 i.e., 37.50 will be taken for reckoning. It is the responsibility of the candidate to obtain and submit marks memos from the competent authorities where ever grades instead of marks are issued.

- Waiting period Weightage: Maximum of 10 marks @ 1.0 mark per completed year from the date of passing qualifying examination to the date of issue of notification.

g. Weightage for contract service: up to 15% will be given to the candidates working / worked on Contract/ Outsourcing / Honorarium basis including COVID-19 service as shown below subject to satisfactory service, certified by the competent authority, as per GO Rt NO 211, HM&FW(B2) Dept., Dt:08.05.2021, G.O.Rt.No. 573 HM&FW(B2) dept. dt.01.11.2021 and GO.Rt.No.07, HM&FW(B2) dept. Dt.06.01.2022, Govt.Memo.no. 3740784/B2/2020 of HM&FW(B2)Dept.,dt.14.02.2022 & read with circular no.03/CHFW/2022, dated. 11.02.2022 of the Commissioner of Health & Family Welfare, A.P. If any individual worked less than six months for COVID, the weightage shall be 0.8 marks per completed month will be awarded.

Weightage to contract service based on type of area:

- a. @ 2.5 marks per six month in Tribal Area.
 - b. @ 2.0 marks per six month in Rural Area.
 - c. @ 1.0 marks per six month in Urban Area.
 - d. No weightage will be given for the services less than six months for non-COVID Service.
 - e. Spells of service rendered will also be considered.
- h. The Specialist doctors (CASS) who have been working / worked on contract/outsourcing/honorarium basis and discontinued for administrative reasons i.e. for want of vacancy will be eligible for contract weight age.
- i. The COVID-19 weightage shall be applicable only to the persons who were appointed by a competent authority authorized under the relevant COVID orders/GOs and are appointed by District Collector or any other competent authority based on orders issued by Government from time to time and certified by the controlling officers (DMHO / DCHS/Superintendent of GGH) to that effect as per G.O.Rt.No 211, HM&FW(B2)Dept., Dt:08.05.2021, G.O.Rt.No.573, HM&FW(B2) dept., dt.01.11.2021 and G.O.Rt.No.07, HM&FW(B2) dept., dt.06.01.2022, Govt.Memo.no.3740784/B2/2020 of HM&FW(B2)Dept., dt.14.02.2022 & read with circular no.03/CHFW/2022, dated.11.02.2022 of the Commissioner of Health & Family Welfare, A.P. COVID weightage will be considered on submission of appointment orders for COVID-19 Management, Monthly attendance certificates and Bank statements indicating payment of monthly remuneration along with COVID service certificate.
- j. Contract service will be reckoned up to the date of notification as per Govt.Memo.no.4274/D1/2013, HM&FW(D1) Dept., dt.10.07.2014.

7. In-Service Candidates:-

- a. Candidates who are already in service shall submit NOC from the HOD concerned (DPH&FW/DME). Candidates who have been working in DSH (formerly APVVP) facilities on regular basis will not be considered either for regular or contract appointment.
- b. Candidates who are already working on regular/contract basis shall submit acceptance of resignation from the competent authority (DME, AP / DPH&FW, AP) for admission to duty, if selected.
- c. Specialist doctors working on contract basis in DSH(formerly APVVP) facilities will not be considered for contract appointment. They will be

considered for regular recruitment only. Specialist doctors working in NHM will be considered for regular/contract appointment.

8. Important information to candidates:

- a. Candidates undergoing PG / Super Specialty course are advised not to apply. Permission will not be given to continue their PG / Super Specialty course under any circumstances, if selected.
 - b. Selected candidates will be posted to any medical institution as per requirement of the department.
 - c. If selected, he/she should stay at the bonafide Head Quarters compulsorily.
- 9.** The recruitment is subject to the outcome of any O.As/W.Ps pending before court and likely to arise in the matter.
- 10.** Director of Secondary Health, AP / APMSRB reserves every right to cancel the notification /alter/modify any condition laid down in the notification for final selection and also number of posts notified.
